SPECIAL THANKS go to Joel Golmont of Smith & Stevenson, representative for Watts Regulator, for his presentation at our August meeting on the problems with thermal expansion. Increasingly, local codes are requiring dual-check backflow preventers at the meter for residential water service. As Joel explained, water in a closed system will expand 2% by volume per 100 degree rise in temperature. This

Discussions continued regarding the requirements of the various national model plumbing codes, and the need for the water purveyor to inform their customers of the potential problem when installing a backflow preventer at their meter. Solutions to the problem of thermal expansion include pressure reducing valves, expansion tanks, and thermal expansion relief valves. The T&P valve on the water heater should not be depended on to handle thermal expansion. The T&P valve was designed as an emergency relief device only.

#### LEGISLATION UPDATE

An upcoming topic of discussion for the Volunteer Chapter will be the recently passed legislation by the State of Tennessee regarding the Tennessee Board of Contractors. The Board is trying to implement regulations to prevent any local authority from requiring a State licensed contractor, or members of their operation, to meet local

requirements, such as certified testers and certified repairers in backflow prevention, Master plumber's license or journeyman's requirements in testing.

Basically, the Board of Contractors is attempting to prevent the Codes Department, State Department, and local water purveyors from weeding out those people who are not properly trained in areas such as backflow testing. If a contractor passes a State Examination, then he and his workers are exempt from any specific requirements.
