


And a Great Time Was Had By All

Legislation Update

The Senate passed S.2019, a Safe Drinking Water Act Reauthorization bill. Deleted from the bill as passed was the "Return Flows" provision. This would have been prohibition the on technology of using the public water mains as a "heat sink" for water-based heat pump systems that utilize returning the cooling water to the water main. It was reported that the Senate did not want a floor fight, as this is a very hot topic in some ares, and they believe that state and communities have sufficient authority to prohibit return

flows. A bill will be passed in the House and then the Conference Committee, a joint Senate/House body, will craft the final version.

As we are all working hard to prevent the possibility of backflow into the water mains, a system that returns cooling water to the water main would be equivalent to foolishness.
