

If you missed the Annual Conference in 2012, plan to attend the 2013 Conference in Chattanooga! Please take time to read the presentation summary below.

Summary of Conference Presentation Titled Legal Issues and Responsibilities

If you attended the TBPA Conference in October 2012, you were privileged to hear the presentation by Troy McPeak, Assistant Attorney General, and William Beasley, Criminal Investigator, for the State of Tennessee. I have attempted to summarize their presentation in case you were not able to attend the TBPA Conference. Their presentation demonstrated how violations can result in both civil liability and criminal prosecution.

As you know, Rule 1200-05-01-.17(6) states that all community water systems must adopt an ordinance or policy prohibiting cross connections and establish an ongoing cross connection program. But, listed below are some things you may not be aware of that Troy McPeak presented.

The "Tennessee Safe Drinking Water Act of 1983" is found at T.C.A. 68-221-701. The definition of a "Cross connection" is found at T.C.A. 68-221-703(7). The powers and duties of the board to eliminate cross connections in the distribution system is found at T.C.A. 68-221-704(2) (B)(ix).

T.C.A. 68-221-711(6) prohibits "The installation, allowing the installation, or maintenance of any cross connection, auxiliary intake, or bypass, unless the source and quality of water from the auxiliary supply, the method of connection, and the use and operation of such cross connection, auxiliary intake, or bypass has been approved by the department."

T.C.A. 68-221-713 provides for civil penalties, civil liability for damages, and criminal prosecution. T.C.A. 68-221-713(a) states: "Any person who violates or fails to comply with any provision of this part, any order of the commissioner or the board issued pursuant to this part or any rule, regulation or standard adopted pursuant to this part is subject to a civil penalty of not less than \$50.00 or more than \$5,000 per day for each day of violation. In addition, such person shall also be liable for any damages to the state resulting therefrom, without regard to whether any civil penalty is assessed."

T.C.A. 68-221-713(f) and (g) further state: "Any person violating, or failing, neglecting or refusing to comply with any of this part or rules or regulations commits a **Class C misdemeanor**. Each day upon which such violation occurs constitutes a separate offense. Any person who willfully and knowingly pollutes or threatens to pollute any public drinking water system in this state or willfully fails, neglects or refuses to comply with any of this part commits a **Class E felony**."

T.C.A. 39-13-103 provides for criminal prosecution in the event of Reckless Endangerment. "A person commits an offense who recklessly engages in conduct that places or may place another person in imminent danger of death or serious bodily injury. Reckless endangerment is a Class A misdemeanor but in some cases can be a Class E felony. Reckless or intentional conduct regarding cross-connection and backflow prevention could lead to charges of reckless endangerment.

T.C.A. 39-14-114 provides for criminal prosecution in the event of forgery. Forgery includes making false entries in books and records such as falsifying documents and falsifying test results. Forgery is at least a **Class E felony**.

T.C.A. 39-16-504 provides for criminal prosecution in the event of destruction or tampering with governmental records.

T.C.A. 39-16-702 provides for criminal prosecution in the event of perjury. Perjury includes making a false statement, not under oath, but in a declaration stating on its face that it is made under penalty of perjury.

T.C.A. 39-16-302 provides for criminal prosecution in the event a person conducts unauthorized practice of a profession. It is unlawful for a person to conduct an activity without a required license or certification. Backflow prevention device testers must be certified.

We are sorry to say that many times cross connection (backflow) is not taken as seriously as it should be. As was demonstrated in this presentation at the annual conference, violations can result in both civil liability and criminal prosecution. Everyone, not just those who manage cross connection control programs, should be aware of these penalties.

Thanks again to both Troy McPeak and William Beasley for an excellent presentation!
